
When I drove around, the clerk, Kenneth Davenport, took my credit card as a form of payment. At this time the manager, Angel Mirabal, approached the window and stated, "He doesn't want to serve you because you are a police officer." Mirabal was referring to Davenport and referenced him by looking at Davenport. At this time, Davenport had not processed my credit card and had to be ordered to do so, by Mirabal. I explained to Mirabal that this made me extremely uncomfortable and now wasn't certain I wanted to dine at the restaurant. Mirabal assured me everything was ok and handed me my food. Mirabal even laughed and said he is allowed to refuse to serve me.

I was uncertain of the condition of my food, and felt for my safety, it would be best not to eat there. I responded inside and Mirabal provided me with a refund. Mirabal provided me with his contact information and store information but Davenport refused to have contact with me, ignored me and refused to provide his contact information to me.
