DESCRIPTION OF INCIDENT: In April of 2013, representatives from the New Life Assembly of God became aware that a series of donation checks had gone missing from their records. These checks were made payable to the New Life Assembly of God, and were donated between September 2012 and February 2013. The investigation revealed that Mr Derosier, a longtime Pastor at the Church, unlawfully took possession of these checks and deposited them into his personal checking account. The checks, which totaled \$2690.00, were drawn off the accounts of 4 Church members.

On 12/2/13, Mr Derosier turned himself in to Pembroke Pines Police Detectives and was charged with Grand Theft. Mr Derosier did not provide a statement.

Probable Cause Affidavit


Before me this date personally appeared **DETECTIVE F. PEREIRA (ID 672)** who being first duly sworn deposes and says that on the 5th day of February, 2013 at 7885 Pines Blvd., Pembroke Pines, FL

defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:
 The Defendant (Derosier) was a Pastor at the Victim Business (New Life Assembly of God of Broward County Florida, Inc.). Investigation revealed that Mr. Derosier unlawfully took possession of eleven checks (totaling \$2,690.00) made payable to the Victim Business, and deposited these checks into his personal Chase Bank account [REDACTED]. Video surveillance provided by Chase Bank shows the Def. depositing at least ten of the eleven checks. The checks were drawn off bank accounts belonging to [REDACTED], and [REDACTED], all of which provided sworn taped statements indicating that the checks were intended for New Life Assembly of God and Jules Derosier was not an intended payee allowed to negotiate or deposit the checks.

Maria Khaleel of New Life Assembly of God advised that, as a result of the defendant's actions, the Victim Business suffered a financial loss of \$2,690.00. Khaleel provided a sworn taped statement indicating that the Victim Business wishes to prosecute.

Derosier surrendered himself and refused to answer questions regarding this investigation. He was then transported to BSO Main Jail for booking


