INCIDENT SUMMARY:

One man is in custody and facing felony charges after a shooting in the parking lot of the Advenir at San Tropez community led to a woman being shot.

At 10:55 a.m. multiple 911 calls reported that gunshots were heard near NW 78 Terrace and NW 3 Street. Police officers immediately responded and found a woman with gunshot wounds. She was transported to a nearby hospital for emergency medical treatment.

Witnesses indicated that the suspect drove away after the shooting. With the assistance of the Hollywood Police, the suspect's vehicle was stopped at the 6200 block of Hollywood Boulevard and Otis Leevel Johnson was taken into custody.

Preliminary investigation confirmed that the victim and Johnson were involved in a previous relationship and have a child in common. Johnson arrived at the victim's home and a dispute involving several people erupted over child custody.

During the dispute, Johnson pulled out a gun and fired shots toward three people – a man, a woman, and the victim. The man and the woman were unharmed. The man, who was also carrying a gun, returned fire but bullets did not hit Johnson. The victim was struck during the exchange of gunfire.

This shooting appears isolated, domestic in nature, and no other people are at large.

Otis Leevel Johnson is charged with attempted murder in the first degree and aggravated assault with a deadly weapon. He was transported to jail and additional charges may be presented based upon the outcome of our investigation.
